### 1. BACKGROUND

#### 1.1.About RWARRI

Rwanda Rural Rehabilitation Initiative (RWARRI) is a national NGO committed to enhancing the social and economic welfare of rural communities in Rwanda. Established in 2003, it is registered with the Government of Rwanda (No. 37/11 14/SC&RT) and the Rwanda Governance Board (RGB No. 023/11).

### 1.2. About YESPAR Project

RWARRI partners with the SUYANA Foundation (Switzerland) to implement Youth Empowerment for Sustainable and Profitable Agriculture in Rwanda (YESPAR), also called "Shaping the Next Generation of Agriculture." The project operates in Rwamagana, Kayonza, and Ngoma districts, equipping youth with practical skills in mechanization, irrigation, and post-harvest handling and storage.

#### 1.3. The Context

To support the effective implementation of training activities/short courses at AMITH TVET School and Kitazigurwa Farm in Kayonza District, RWARRI seeks to procure student training uniforms and workshop (mechanization) uniforms. These uniforms are essential to ensure standardization, safety, identity, and professionalism during both theoretical and practical training sessions

#### 2. OBJECTIVES OF THE ASSIGNMENT

#### 2.1. Main Objective

To procure and supply quality student and workshop uniforms for trainees participating in YESPAR Project activities at Kayonza.

### 2.2. Specific Objectives

- Provide standard student uniforms suitable for classroom and practical session activities.
- Provide protective workshop uniforms appropriate for mechanization and field-based practical training.
- Ensure all uniforms meet quality, durability, and safety standards.
- Ensure timely delivery of uniforms to AMITH TVET School.

### 3. SCOPE OF WORK

The contractor shall be responsible for procuring and delivering student and workshop uniforms as outlined below.

### 4. DELIVERABLES

- Supply of all student and workshop uniform items as specified in Section 3.
- All uniforms must be new, of good quality, durable, and free from defects.
- Uniform sizes shall be based on a list provided by RWARRI before procurement.
- Delivery of all uniforms to AMITH TVET, Eastern Province, Rwanda.

**NB:** The supply and production of student uniforms shall commence on the very first day of student enrollment, after individual student measurements are taken at the school to ensure proper fitting. Workshop (mechanization) uniforms shall be supplied immediately after signing the contract.
